**AMENDMENT OF DEDICATION AND RESERVATIONS  
OF  
CASCADE ADDITION**

Having acquired the written vote of the owners of a majority of the lots, copies of which are attached hereto, the following amendments are made to the Dedication and Reservations of Cascade Addition filed in Book 1616 at Page 386:

1. The Cascade Homeowners' Association is hereby merged with the Homeowners' Association of Cascade Estates with the Cascade Estate Homeowners' Association being the surviving entity.

2. The Cascade Estates Homeowners' Association will assume the responsibilities of maintaining the entrance easement and other community easements, promotion of community activities and enforcement of Cascade Addition Protective Covenants.

3. The Cascade Estates Homeowners' Association will assume said responsibilities for and in consideration of the payment of homeowners' dues in the amount of \$78.00 per lot for the current year and \$150.00 per lot beginning in 2001 and thereafter.

4. Residents of Cascade Addition, by payment of said homeowners' dues, will have access to the Cascade Estates swimming pool, playground and other common and/or public elements.

5. The residents of Cascade Addition shall, in all ways, be active and eligible members of the Cascade Estates Homeowners' Association as long as the terms and conditions of the Cascade Estates Homeowners' Association are observed.





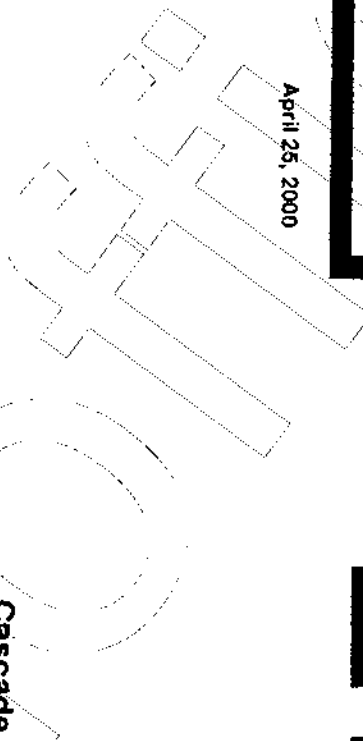
