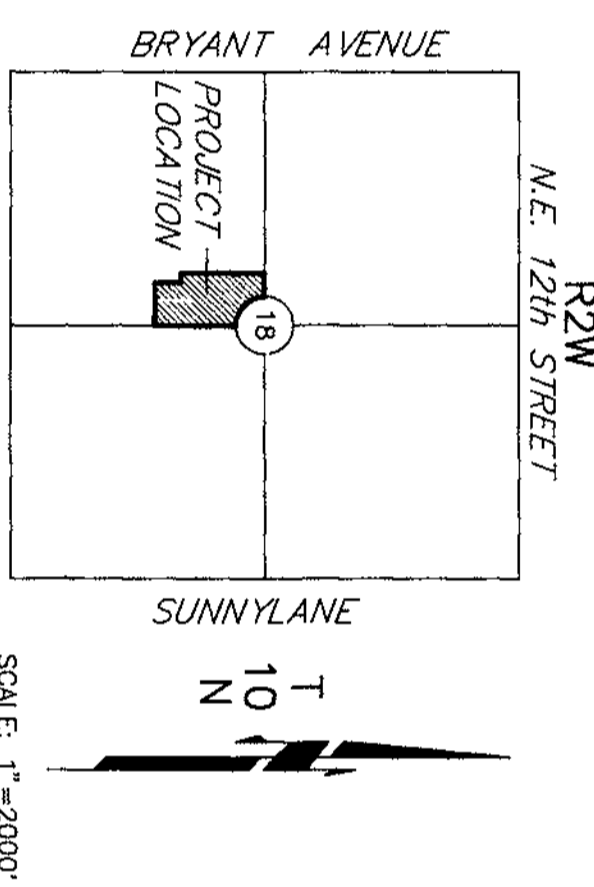
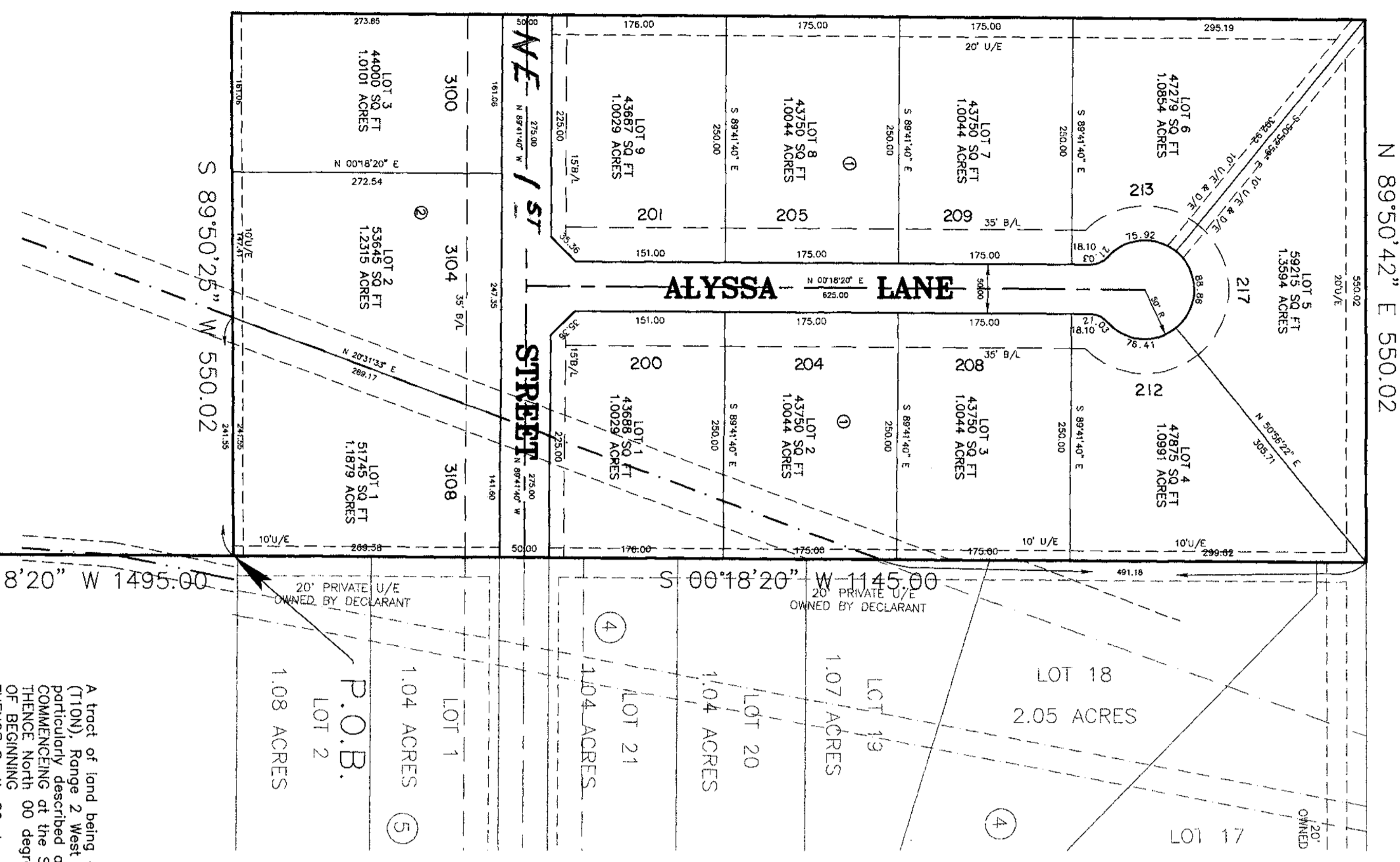


FINAL PLAT
