I

That Section 17 of the Declaration, styled "FENCES" be eliminated in its entirety and the following inserted

FENCES: No fences shall be installed on the front portion of a lot in this subdivision 17 between the front lot line and the front building set-back line, except on a corner lot the fence may be installed five (5) feet beyond the side yard set-back line Fences shall be constructed of wood plank, stockade, or similar wood materials or stone or brick. All other fences must be approved by the ACC.

When any portion of a lot abuts Common Area "A", the fence cannot exceed four (4) feet in height and must be constructed of wrought iron and of the standard pattern and design approved by the ACC

Privacy fences may be constructed near the rear of the house if said privacy fences do not obstruct the view of the greenbelt by adjoining property owners. All fences and their location must be approved by the ACC

All other provisions of all the Protective Covenants shall remain in full force and effect
