
The undersigned, property owners in Summit Lakes Villas Property Owners Association representing in aggregate ownership interests of 90% or more of the Common Elements affecting lots, do hereby amend the Declaration (and the By-Laws) for Summit Lakes Villas Property Owners Association filed of record in office of the County Clerk of Cleveland County, Oklahoma on 5th day of August, 1999 and indexed against the following described real property in Cleveland County, State of Oklahoma, to wit:

1. By amending Section 2.11 from its present language to the following , to wit:

Section 2.11. Visitor Parking Areas. Visitor Parking Areas are reserved exclusively for temporary parking by invitees of either Owner or occupants of Dwellings. Subject to applicable laws, ordinances, and this Declaration, any vehicle parked or standing in violation of the restrictions set forth herein, for more than 72 hours after notice from the Association is posted on such vehicle, shall be subject to towing by the Association, at the violating Owner's sole risk and expense. The Association shall not be liable to the Owner of such vehicle for trespass, conversion or otherwise by reason of such towing. The Association shall not be liable for the removal or failure of the Owner to receive the notice once given and an affidavit of the person posting the notice stating that it was properly posted shall be conclusive evidence of proper posting.


